The tragedy that occurred in Beslan on September 1-3, 2004 impacted many people, including us – the Murtazov family. Four of us were held hostage. Every one came out with injuries and wounds. Our daughter, Diana Murtazova (year or birth - 1990) suffered the most. Her condition required a complicated vascular surgery, and rehabilitation.

In the beginning of July 2006 we received a phone call from America: Andrew Mogilyansky offered to help. In September 2006 we flew to America. There, we were welcomed by Andrew, who accommodated us in his house and made sure that all our needs were met.

Diana's treatment and rehabilitation started on September 27, 2006 and ended on February 21, 2007. When the course of treatment and rehabilitation was completed, Andrew arranged our flight from the USA to Moscow.

We also know that Andrew provided various assistance to many people who suffered from the Beslan tragedy. We are grateful to Andrew, his family and friends for all the care and help they provided to us during our stay in the USA.
