But this has become possible because of invaluable help of the president of International Foundation for Terror Act Victims, Andrew Mogilyansky. Thanks to the financial assistance provided by his Foundation, in 2008 my daughter underwent a course of treatment and rehabilitation in Germany.

Starting with September 2004, we desperately needed considerable funds to pay for my daughter's lengthy and difficult recovery. We are a normal, medium-class family, and it would be much more difficult and complicated to restore my daughter's health without the assistance of Andrew Mogilyansky and his Foundation.

My daughter and I are very thankful to him. We also want to thank him on behalf of all the victims of the Beslan tragedy, who are very grateful to him.
